Ed explained the principles of DOVE, and several specific interventions designed to move beyond objective assessment and enhance Career Decision Making Self-Efficacy. bership Chair for the National Career Development Association (NCDA).

Attendees learned how to use DOVE techniques to translate psychological data into values-based terms that facilitate career life decision making.
